I understand that during my participation in the above hunt, I may be exposed to a variety of hazards and risks, foreseen or unforeseen. These hazards and risks include, but are not limited to, damage to property, personal injury, illness or my death from exposure or other danger (“injuries and damages”) during the outing. I know that injuries and damages can occur from natural causes or through the activities of animals, hunting partners, or other persons, and such injuries and damages can occur as a result of negligence or otherwise. I understand that I may have to exercise extra care for my own person as well as for others around me in the face of such hazards and risks. I further understand that on group outings there may not be a rescuer or medical facilities or anyone with expertise necessary to deal with the injuries and damages to which I may be exposed.

I confirm that I have read the Information for Hunters sheet.

I confirm that I have read this Waiver document in its entirety and I appreciate, understand, and voluntarily assume all risks of such injuries and damages and notwithstanding such risk, I agree to participate in the hunt.

As well and in consideration of my acceptance as a participant in this outing, I hereby waive any rights I may have to make claims for and I release and discharge the Nature Conservancy of Canada and its officers, directors, employees, contractors, agents, volunteers and leaders from all liability or responsibility for any injuries and damages I may suffer, howsoever caused, and even though such injuries and damages may result from negligence, whether passive or active.

This assumption of risk, waiver and release is given on my behalf and is binding upon my heirs, executors, administrators, successors and assigns.
